- I. Haryana Khadi & Village Industries Board has been in operation since 1969 for organizing, developing & promoting Khadi & Industries in the Rural area of the state. It is engaged purely in developmental programmes aimed at creating employment opportunities in the rural area. The board undertakes these activities without any profit motive.
- II. Schemes: Board is providing financial assistance to the rural entrepreneurs for setting up Industrial unit in the rural area in the state under (PMEGP) Primer Minister Employment Generation Programme. This scheme is operated through commercial Banks/Cooperative Banks/Public Sector Banks for providing employment opportunity to the rural youths.

**Financial Assistance under PMEGP scheme:**

- I. Ceiling limit of the project cost is Rs. 25.00 lakhs.
- II. Under the scheme, the borrower is required to invest his own contribution of 10 percent of the project cost in case of General category and 5 percent in case of weaker section, women and ex-serviceman.
- III. Banks will sanction 90 percent of the project cost in case of general category and 95 percent in case of weaker section and women and ex-servicemen and disburse full amount of the loan.
- IV. Board provides 25% margin money of the project cost in case of general category and 35% in case of weaker section and other categories of women and ex-servicemen.

**Eligible activities:**

All activities which do not appear in the negative list circulated by Khadi & Village Industries commission are eligible for financing under the scheme.

**Negative List:**

1. Any industry connected with meat/slaughter or any intoxicated items.
2. Agriculture sector, dairy, fisheries, piggeries and poultries etc.
3. Manufacturing of polythene carry bags of less than 20 microns.
4. Item causing environment problems/hazards.

**Entrepreneurship Development Programme (EDP):**

Two weeks EDP training will be provided to the beneficiaries after the sanctioned of loan by the banks for the awareness of beneficiary pertaining to various managerial and operational functions like finance, production, marketing and banking formalities etc.

**Essential Requirements:**

Loan application supported by essential documents such as project report, machineries quotations N.O.C. from Sarpanch, Experience Certificate Educational Certificates, Photo copy of ration card and proof of site etc.
